# **Staffing Updates**

Amanda Dyer: Phase I MS4 CoordinatorMariapaz Moreno: Program Support

## **Phase II Designations**

- Kristie is working on a list of potential new designees. Currently anticipate 30-70.
  - o Urban Area (2020 U.S. Census)
  - o Adopted TMDLs/BMAPs
  - o petitions
- Newly designated MSs may join an existing Ph. I permit as a co-permittee according to Rule 62-624.810, F.A.C.:
  - (2) If the Phase II MS4 is in the same urbanized area as a Phase I MS4 with an NPDES stormwater permit and the permitted Phase I MS4 consents, in writing, to allow the regulated Phase II MS4 to participate in its stormwater program, the Phase II MS4 and the existing Phase I MS4 may jointly seek a modification of the original Phase I MS4 permit to include the newly regulated Phase II MS4 as a co-permittee. As a co-permittee, the Phase II MS4 will be responsible for compliance with the permit's conditions applicable to its jurisdiction. If a Phase II MS4 pursues this option the proposed permittee must comply with the permit application requirements of Rule 62-624.400, F.A.C., which incorporates 40 C.F.R. 122.26, rather than the requirements of this section, Rule 62-624.810, F.A.C.
  - o Terry Carr (City of Jacksonville) asked for clarification regarding who decides whether

they could join or not.

- Michelle: It would be a joint decision between affected parties as described in the rule. All co-permittees must agree.
- o Joseph Thames (St. Petersburg) who in Pinellas County is on the list for designation?
  - Michelle: Possibly Bellaire Shores, but the list is currently being generated and is not complete.

#### **Training**

- The program is developing training on MS4/DEP responsibilities. This will be presented to DEP districts and MS4s at the next quarterly teleconference (tentatively).
- The program is developing a new MSGP non-filer referral process. This will ensure that the NPDES Stormwater Program Notice Center has the information necessary to determine whether a facility is regulated.

#### **Surveillance fees:**

- Invoices are sent in early December and are due January 15, 2025.
- Program staff are auditing our contact list to ensure invoices are sent to the correct staff. They may reach out to permittees to confirm financial officer contact information soon.
- After invoices are sent, each contact will receive a "Balance Statement" around February 15.
  - o Check these statements for a zero balance, or a "Past Due" balance.

# **Permitting updates**

- The permit template is complete
- The program will issue 2-3 draft permit packages; hopefully by the end of November 2024.
- After those drafts are sent, the program intends to send decision schedules (hopefully by December) for all permits whose applications are complete; to provide a timeline.
- Program is initiating rulemaking on 62-624 to repeal the annual report form (DEP form 62-624.600(2)) and replacing it with permit reporting requirements.

#### **eReporting**

- DEP is developing a new permit/compliance database called PLUMS (Permit Lifecycle Unified Management System), which will include MS4 permitting and annual reporting, including TMDLs, assessment programs, and other annual reporting attachments due.
- NPDES Stormwater is scheduled to begin working on database development in January 2025.

# **<u>State Stormwater Rule</u>** (Environmental Resource Permitting) – Borja Crane-Amores

- Borja discussed ERP requirements and the relationship with MS4 requirements following adoption of revisions to Chapter 62-330, F.A.C.
  - O&M Manual: MS4 entities are not required to submit O&M plans; they shall conduct operation and maintenance of the ERP-permitted stormwater management systems according to their MS4 permit requirements (Section 12.4.1, <u>ERP Applicant's Handbook Volume I</u>, June 28, 2024)
  - o Inspections: MS4 entities shall conduct and report inspections of ERP-permitted MS4 stormwater management systems according to MS4 permit requirements and

- associated SOPs. (Section 12.5(b), <u>ERP Applicant's Handbook Volume I</u>, June 28, 2024)
- Form 62-330.301(26), "Certification of Financial Capability for Perpetual Operations and Maintenance Entities" is required by all applicants, including regulated MS4s.
   (Chapter 12, ERP Applicant's Handbook Volume I, June 28, 2024)

# Q & A / Open Discussion

- Jessica McPherson (Lee County) stated that they were under the impression that they were not getting audited until after the new permit was issued.
  - o Michelle: we conduct audits of each permittee every 5 federal fiscal years (FFY), October 1 to September 30, not based on permit cycles.
- Robert Potts (RES) asked about eReporting and how PLUMS will be used going forward and how Ph. IIs will deal with eReporting with respect to the DEP Business Portal.
  - Michelle: We halted development of Phase II reporting in the Business Portal, but those anticipated functions will likely get transferred to PLUMS. We anticipate that annual reports will be due electronically after those permits are issued in PLUMS; however, that discussion has not happened yet.
- Anne Capelli (Mock Roos) asked when the potential Ph. II designation discussions may take place.
  - Michelle stated the list will potentially come out in the next month or two. In this first year, we will primarily focus on developing outreach, before we reach out to potential permittees. We anticipate contacting potential designees 9 to 12 months from now.
